Criteria for Volunteer Approval

1. A criminal history check will be performed on each volunteer.
2. Volunteers may be denied due to any of the following:
 - a. Felony conviction or deferred adjudication within the past five years.
 - b. Individual having a conviction or deferred adjudication for indecency/sexual crimes.
 - c. Individual that is a registered sex offender.
 - d. Individual that has been incarcerated in the Lubbock County Detention Center or other correctional facility within the past two years.
 - e. Individual that has pending charges.
 - f. Individual that is currently on probation or parole.
 - g. Individual that has been removed as a volunteer due to a rule or other violation.
 - h. Individual that has nepotism connections to anyone in the Lubbock County Jail. (Nepotism is defined in the Lubbock County Personnel Handbook)
